

GENERAL PROVISIONS ON STUDENT CONTRIBUTION/TUITION FEES

Students Who Are Required to Pay Contribution/Tuition Fees:

- When students enroll in a second university program with a previous enrollment in a program at another university or open education, those who enroll in the second program and have their last enrollment at our university;
- As the student contribution is covered by the government only for 1 year at the preparatory level, students who exceed this period and are still at the preparatory class;
- Excluding the Preparatory Class, students who exceed the normal length of programs at bachelor's, master's or doctoral levels;

- International students who would like to enroll at our university within the scope of international student admissions and those who continue their education at our university;
- Students pursuing a double major;
 - Students who double major pay for the duration of the degree program and an additional contribution/tuition fee at the end of the year. For that reason, our students
 - in the 9th and 10th semesters of their majors, pay the contribution/tuition fee for the major program if they have major and double major registrations. If they only have a double major registration, they do not pay any fees.
 - in the 11th and later semesters of their majors, pay the contribution/tuition fee for the major and double major programs if they have registrations for both.
 - in the 11th and later semesters of their majors, pay the contribution/tuition fee for the double major program if they only have a double major registration. With only a double major registration, they do not pay any fees.
- Students who pursue a minor pay the contribution/tuition fee for the minor if they have completed the major degree, but continue studying in the minor.

- Except for those who hold a scholarship from overseas organizations, Syrian students who are hosted in our country due to the situation in the Syrian Arab Republic pay the tuition fee determined for International Students based on their choice of education if they study at an associate, undergraduate, or graduate degree level with their own means or pursue their education with their own means within the scope of the Part (B), Article (a), paragraphs 2 and 4 of the Provisions Concerning International Student Admissions.

When a student is removed from the support program after acquiring Turkish citizenship, they are subject to the fees specified for international students.

- Among the Syrian citizens who are hosted in our country due to the situation in the Syrian Arab Republic, students who enroll in the special programs opened for them pay the fee specified for international students.

- When students enroll as part of the international student admissions,

- if they hold a blue card (mavi kart),

- if they are Turkish nationals and have pursued the secondary education wholly in a foreign country excepting TRNC,

- if they have pursued the secondary education wholly at a Turkish school abroad excepting TRNC,

- Students who registered before the 2021-2022 academic year; will not pay the tuition fee, those who cannot graduate within the program period will pay the tuition fee.

- However; students who register in the 2021-2022 academic year and later will pay tuition fees.

- Since the fees of international students who have completed high schools abroad which are included in the list published by YTB, will be covered by YTB, these students will not be charged tuition fees.

- Students coming from abroad or going abroad within the scope of Erasmus or Mevlana exchange programs are subject to the regulation of their own higher education institutions in terms of contribution and tuition fees. AGU students pay their contribution and tuition fees to AGU when they take courses at overseas or other national universities due to Erasmus, Mevlana or Farabi schemes.

- Special students attending another higher education institution based on the affirmative decisions of concerned Universities' Senates pay relevant contribution/tuition fees to the higher education institution they are enrolled at.

EXEMPTION FROM AND DISCOUNT ON Contribution/Tuition Fees:

- Students who declare that they are martyrs or veterans' children with the "**Certificate of Entitlement**" obtained from the Social Security Institution do not pay the contribution/tuition fee. (Original documents must be handed over during the registration period.)

- RESEARCH ASSISTANTS working at a State Higher Education Institution do not pay the contribution fee with a document issued by their workplace proving that they are Research Assistants in case that they are graduate students at daytime education and cannot graduate during the normal length of education. However, if they have enrollment at a second university, they pay the relevant fee.
- Students with disabilities receive a rate of discount on the tuition fee based on their disability degrees with the "Medical Board Report" to be obtained according to the Law on People with Disabilities and Classification of Disability Degrees and the Regulation Governing Medical Board Reports to Be Given to People with Disabilities. (Original copy of the Medical Board Report must be handed over during the registration period.) Students with disabilities who submit their "Medical Board Reports" do not pay the contribution fee even after they reach the maximum length of education.
- Students who will only take one exam for a "SINGLE COURSE" in an academic semester do not pay the Contribution/Tuition Fee.
- Students who pay the contribution and tuition fees with enrollment but later decide to cancel their enrollment of their own volition are not reimbursed.
